**Secretarial Compliance Report of Maruti Infrastructure Limited
for the financial year ended 31st March, 2025**

I have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **Maruti Infrastructure Limited** (hereinafter referred as 'the listed entity'), having its registered office at 802, Surmount Building, Opp. ISCON Mega Mall S. G. Highway Ahmedabad-380015.
